Sponsored 25 partner groups in securing public agency grants (22 Neighborhood Matching Funds, 3 King County Conservation District). Awarded \$346,500 from the Stim Bullitt Park Excellence Fund to six community partner groups (and one advocacy effort). Planned first annual Community Partner Convening to share resources and experience collective impact for open space issues in Seattle. Expanded tree planting program in Duwamish Valley; including community-based training and job creation for young adult residents. Partnered on the completion of the Fitness Zone Program; installing Fitness Zones at Powell Barnett, Delridge, Hiawatha, and Van Asselt Parks. Broke ground on the campaign to expand Rainier Beach Urban Farm and Wetlands.

Funding and in-kind resources for "Vote No on 123" campaign. Conducted a staff workshop on Diversity, Equity and Inclusion. This created a framework to advance equity in our community-driven open space work. Hired Duwamish Valley Program Manager to coordinate community-driven open space planning in South Park and Georgetown, convened coalition of 15 nonprofit and City organizations to redefine large-scale community-driven planning in the Duwamish Valley, initiated Georgetown Vision Framework process. Convened Open Space Steering Committee to begin planning for Rainier Beach vision process. Contributed to City-led Equity & Environment Agenda to engage communities of color in city-wide environmental work. Coordinated with Office of Sustainability and Environment and newly-formed Office of Planning and Community Development to increase community input into City planning processes.
